## Anonymous Browsing and Plan Shopping

#### Changes to Plan Shopping and Anonymous Browsing

Each year Plan Management makes updates to the anonymous browsing (AB) and plan shopping space to provide a more efficient shopping experience and to provide the most relevant plan and cost information. This year's changes include:

- Populate city/county based on zip code
- Prompt to encourage income information
- X Value plan indicator on plan tile
- X OOP costs for telehealth added to plan tile
- A family planning section added to plan details page (includes abortion care, birth control, and infertility treatments)
- Dental waiting period indication on plan tile
- A page dedicated to information about vision plans and a link to purchase a plan is now available on MHC. VSP is the current participating vision carrier.



# 2024 Plan Updates

### 2024 Plan Updates

The following requirements were approved by the MHBE Board and applied to 2024 plans:

- X Link to actual plan contract should be available in the Summary of Benefits and Coverage.
- X Value plans now have a standardized cost share for commonly used services. Authorized carriers (health) must offer one plan at each metal level that adheres to the value plan standards. These plans must include "value" or "value plan" in the plan name. Value plan standards from previous plan years are retired.
- X The upper age limit for Young Adult Subsidy eligibility raised from 34 years of age to 37.
